### Early Career Liaison program

We received six applications for the Early Career Liaison program. Melanie Beasley (Assistant Professor, Purdue University) was chosen as our new Early Career Liaison. In her application, Professor Beasley described the absence of programming tailored specifically to the needs of early career members of AAPA. To develop such programming, she proposed to form an ad hoc committee of early career members. The charge of the committee is to establish an informal annual event—mixer or meet-and-greet—focused on the specific challenges and complexity of navigating professional opportunities beyond the PhD. Professor Beasley will shadow the Chair of the Committee on Career Development, Shara Bailey, and liaise closely with the Committee on Diversity and the Committee on Media & Communication. We wish her the best during her appointment as the AAPA Early Career Liaison, and we thank Kevin Hatala for his service as outgoing Early Career Liaison.

## Cobb Professional Development Grants (CPDG)

The AAPA CPDG committee reviewed 31 eligible applications in 2019-2020. As in the past, we received several applications from outside of the USA and many projects involved international work and collaborations. Overall, the pool of applications was strong, representing the scholarly breadth of AAPA. Each application was reviewed by three committee members and the Chair. In reviewing proposals, the committee considered the significance of the work, the quality of the proposal, the potential impact of the award on the applicant's career, and the strength of the recommendation letter and CV. The committee endeavored to fund broadly across the discipline and career stages. The committee recommended funding five proposals, each in the amount of \$7500. Award and declination letters were emailed to applicants on March 8, 2020. The award recipients are as follows:
